#### 1. ROLE SUMMARY

Autoridade Nacional do Petróleo (ANP) is Timor-Leste public institution, created under Decree Law No. 62/2023, of 6<sup>th</sup> September, 3<sup>rd</sup> amendment of Decree-Law No. 20/2008 of 19<sup>th</sup> June, on the Autoridade Nacional do Petróleo, responsible of managing and regulating petroleum activities in Timor-Leste area, both offshore and onshore and in the Greater Sunrise Special Regime in accordance with the Decree Law on the establishment of the ANP, the Timor-Leste Petroleum Activities Law and Maritime Boundary Treaty.

The ANP is to establish and supervise compliance with the enacted rules and regulations covering the exploration, development, production, transportation and distribution of petroleum, natural gas resources and mineral. It is also tasked to develop a strong petroleum and mineral management institution in Timor-Leste.

As a public institution ANP carry's out several programs in to providing e assistance for Timor - Leste National in the area of work practices through one of the programs namely Graduate Internship Program (GIP), which is to assist Timorese graduates, introduce to them to real work practices and experience professional working environment where they are qualified to compete in the job market a as prepare for future suitable career opportunities.

The stakeholder's engagement aims to establish a proactive coordination between all relevant parties and institutions ranging from International, national and community levels which potentially involve directly or indirectly with the petroleum operations activities where to strengthen participation in the implementation of Local Content.

# 2. KEY OBJECTIVE

- 2.1. To learn the importance of Stakeholders Engagement roles in the implementation of local content through the enhancement of Timor-Leste Nationals employment and training in petroleum operation in Timor-Leste;
- 2.2. To learn the importance of Stakeholders Engagement roles in encouraging active participation of stakeholders in the petroleum operation in Timor-Leste.

- 3.6 To learn the implementation of Local Content and Procurement of Goods and Services giving impact to the local economic development.
- 3.7 Responsible for ensuring a maximum public and community awareness, as well as good cooperation from the local authorities and local communities in supporting executions of the exploration activities;



- 3.8 Responsible for facilitating the ANP management and relevant entities, as well as local communities in settling certain issues that might arise in relation to the executions of the exploration activities,
- 3.9. To learn on how ANP ensures the implementation local content commitment by operators and its sub-contractor.
- 3.10. Learn to work closely with team members across various department to ensure cohesive stakeholder engagement efforts.
- 3.11. Support the planning and execution of stakeholder engagement events, such as workshops, forum and community meetings.
- 3.12. Help coordinate with logistics, including venue selection, participant invitations and materials preparations.
- 3.13. To learn the Local Content diversification project implementation mechanism and coordination process with stakeholders.
- 3.14. Learn any other learning materials as per indicated at the approval syllabus in place.
- 3.15. Deliver a presentation on all learning topics under the GIP
