SundaGas – Chuditch-2 Appraisal Well Drilling (PSC TL-SO-19-16)

- 1. Authorized Person: SundaGas Banda Unipessoal Lda
- 2. Location of the proposed project: Chuditch-2, located in the Timor-Sea approximately 185km south of Timor-Leste (PSC TL-SO-19-16).
- 3. Type and dimension of the proposed project: SundaGas is planning to construct an appraisal well, Chuditch-2, based on the interpretation of reprocessed 3D 'Kyranis' seismic data, using a suitably designed and capable self-elevating Jack-Up Rig. The appraisal well is expected to be drilled in approximately 68 m water depth and to a target depth of approximately 3,000 m Total Vertical Depth (TVD) in the Plover Formation. The drilling campaign is scheduled for Q2 of 2025, and it is expected to last 40 days. The appraisal well aims to determine the hydrocarbon reserves within the Chuditch-2 field to facilitate future production planning.
- 4. SundaGas intends to implement an appraisal well drilling in the mentioned location.
- 5. In accordance with Decree-Law No. 39/2022 of 8th June 1st amendment to Decree-Law no. 5/2011 of 9th February on Environmental Licensing and Decree-Law No. 32/2016 of 17th August on Offshore Petroleum Operations, the proposed project is classified as a Category A project and shall subject to environmental impact assessment process as specified in the referred Decree-Laws.
- SundaGas shall carry out public consultation on the draft Environmental Impact Statement and Environmental Management Plan prior to submitting the referred documents to the Autoridade Nacional do Petróleo (ANP), which acts as the Environmental Authority for the oil and gas sector.
- 7. The draft Environmental Impact Statement and Environmental Management Plan are available for public consultation.
- 8. The draft Environmental Impact Statement and Environmental Management Plan are ready for public review, during working hours, without any fees, in the following locations:
